

SOCIAL NETWORKS PRIVACY POLICY

1. USER INFORMATION

Who is responsible for processing your personal data?

FLY Gran Canaria SL, from now on, **RESPONSIBLE**, informs the **USER** that it has proceeded to create a profile in the Social Networks Facebook, Instagram, Twitter, LinkedIn, Youtube, Vimeo and Google+, which is the responsible for the processing of the user's personal data carried out on these social networks and informs you that these data will be processed in accordance with the provisions of Regulation (EU) 2016/679 of 27 April (GDPR) and Organic Law 3/2018 of 5 December (LOPDGDD), and therefore provides you with the following information on the processing:

Why do we treat your personal data?

End of the treatment: to maintain a relationship between the USER and the RESPONSIBLE that can include the following operations:

- Processing requests and queries made to the person in charge
- Report on activities and events organized by the person in charge
- Inform about products or services offered by the responsible.
- Interact through the official profiles.

For what reason can we process your personal data?

Legal basis for processing: article 6.1.a GDPR, the person concerned has given his or her consent to the processing of his or her personal data for one or more specific purposes. The USER has a profile in the same social network and has decided to join the social network of the RESPONSIBLE showing interest in the information published in it, therefore, at the time of requesting to follow our official profiles, he provides his consent to the processing of those personal data published in his profile.

The USER can access at all times the privacy policies of the social network itself, as well as configure their profile to guarantee their privacy.

The RESPONSIBLE person has access to and treats that public information of the USER, especially his contact name. These data are only used within the social network itself and will only be incorporated into a file belonging to the LIABILITY MANAGER when necessary to process the USER'S request.

How long will we keep your personal data?

Data conservation criteria: they will be kept as long as the USER does not revoke the consent given as indicated in this privacy policy.

To whom do we provide your personal data?

Communication of the data: the information provided by the USER through the RESPONSIBLE's social networks, including his/her personal data, may be published, always depending on the services that the USER uses, so it may be publicly available to other third party users of the social networks. From the profile of each social network, the USER can configure what information he/she wants to make public in each case, see the permissions that have been granted, delete them or deactivate them, like any application from a third party that he/she no longer wishes to use.

No communication of personal data to third parties outside the social network is foreseen except, if it is essential for the development and execution of the purposes of the treatment, to our suppliers of services related to

communications, with which the LIABILITY PERSON has signed the confidentiality and processing contracts required by the current privacy regulations.

What are your rights?

The rights of the USER: they can only be satisfied in relation to the information under the control of the LIABILITY MANAGER.

- Right to withdraw consent at any time.
- Right of access, rectification, portability and suppression of your data, and of limitation or opposition to its treatment.
- The right to file a complaint with the supervisory authority (www.aepd.es) if you consider that the processing is not in accordance with the regulations in force.

2. PROFILE USAGE

The RESPONSIBLE person will carry out the following actions:

- Access to public profile information.
- Publication in the USER'S profile of all the information already published in the LIABILITY COMPANY's social network.
- Send personal and individual messages through the channels of the social network.
- Updates of the page status that will be published in the USER'S profile.

The USER can always control their connections, remove content that no longer interests them and restrict who they share their connections with; to do this they must access their privacy settings.

3. PUBLICATIONS

The USER, once he is a follower or has joined the social network of the RESPONSIBLE, may publish in this commentary, links, images, photographs or any other type of multimedia content supported by the same. The USER, in all cases, must be the owner of the published content, enjoy the copyright and intellectual property rights or have the consent of the affected third parties.

Any publication on the social network, be it text, graphics, photographs, videos, etc., which violate or are likely to violate morals, ethics, good taste or decorum, and/or which infringe, violate or breach intellectual or industrial property rights, the right to an image or the law, is expressly prohibited.

In these cases, the RESPONSIBLE party reserves the right to immediately withdraw the content, without prior notice, and may request the permanent blocking of the USER.

The RESPONSIBLE will not be responsible for the contents freely published by a USER.

The USER must bear in mind that his publications will be known by other users, so he is the main responsible for their privacy.

The images that may be published on the social network will not be stored in any file by the LIABILITY PERSON, but they will remain on the social network.

4. DATA OF MINORS OR PEOPLE WITH SPECIAL ABILITIES

The access and registration through the social networks of the RESPONSIBLE is forbidden to people under 18 years old. On the other hand, if the USER has special capacities, it will be necessary the intervention of the holder of his

parental authority or guardianship, or of his legal representative by means of a valid document that accredits the representation.

The LIABILITY PERSON will be expressly exonerated from any responsibility that could be derived from the use of the social networks by minors or people with special capacities. The LIABILITY COMPANY's social networks do not consciously collect any personal information from minors, therefore, if the USER is a minor, he/she should not register or use the LIABILITY COMPANY's social networks or provide any personal information.
